Minutes, August 14, 2012

10:00 a.m.

I. Call to order

A. President Kerr called the meeting to order at 10:06. He commended the Senators for their hard work over the summer.

President Kerr reminded the Senate that meetings are conducted with the tradition of Robert's Rules of Order. He advised us to address each other consistently using honorary titles as senator, secretary, vice-president, president in the meetings. The minutes will always use these titles. Disagreements and oppositions are encouraged with decorum always promoting a climate of respect.

Senator Onwumere objected that these titles are too official. He prefers discussion on a first name basis. He also mentioned that the senators are official representatives of their school or college within the university and suggested that the senator's designation could reflect that when used formally.

President Kerr noted that we will look at Robert's Rules of Order and follow it. When we have an approved set of By-Laws, they may address this issue.

B. Approval of the minutes from June and July.

Some minor additions and corrections were made to the minutes and they were approved. The approved minutes will be saved in Pdf format for the Senate's records.

C. A quorum of the senate was present. (See Attachment E) The College of Education had a meeting that conflicted with this August meeting and resulted in the absence of the COE senators. The regular published calendar of Senate meetings for the fall will hopefully prevent future conflicts of schedule.

President Kerr reviewed the agenda for the Faculty Senate as they lead the HSSU Pre-Institute morning on August 15 from 9:00-12:00.

- Guests from Webster University, the University of Missouri, and Maryville University will have a panel discussion: "Senate, Institutional Success and Challenges, Role of Faculty in Shared Governance".
- From 11:00-12:00 the faculty and senators will break into working groups to discuss questions of shared governance at HSSU.

Four Senate meetings for each semester will be planned.

Other meetings will be called as needed. All of the meetings listed will be for the Senators and any interested faculty members.

Private planning meetings just for Senators are also possible. Secretary Pier suggested that the Senate might consider brief caucus sessions right after Friday Faculty meetings since we would all be together at those times.

Roberts Rules of Order will be observed in all meetings especially the conventions of making a motion, seconding a motion, discussion and voting.

B. PRIVATE AND CLOSED SESSION S: TBD

No private or closed sessions are currently planned, but senators will communicate by email as recordings of the Breakout Sessions on August 15 and other further ideas about senate business are discussed. When the Faculty Senate website is available on–line, more opportunities to interact between official meetings will become easy to share and comments, suggestions and proposals from the faculty will be encouraged.

Even though seating is limited in the Hyram Seminar Room, we will invite all interested faculty and we will bring in additional seating if required. Transparency of faculty senate business is a priority.

VII. TEACHER OF THE YEAR SUBCOMMITTEE

A. FACULTY SUBCOMMITTEE WILL SELECT NOMINEE(S) BY 9/23/12

A proposal to select a nominee for Teacher of the Year was made by Senator Carr. It was seconded by Senator Omunwere:

The HSSU Faculty Senate will accept the responsibility of setting out the process for selection of The HSSU Teacher of the Year. We will set out the process and criteria by September 10.

This proposal was voted on and accepted by the Faculty Senate.

Discussion followed about the process:

- Students need a voice. Franchisement of students is the heart of our product.
- Currently the Teacher of the Year is Robert Kamkwalala from the Anheuser-Bush School of Business. So the senate discussed a process of rotating the honor among the HSSU colleges and school by year in alphabetical order:

ABSB – 2011 and then in 2014;

CAS, the College of Arts & Sciences would elect in 2012;

COE, the College of Education would elect in 2013.

• Operational details for the selection would be up to the colleges/school within the criteria that is set forth by the Emerson Foundation which offers the award each year.

• Some discussion was held about the role of the College Deans in the selection process. A consensus was that the deans would not have a vote. The faculty would select "one of their own" and present their nominee to their Dean.

President Kerr said that he would forward the senate's recommendation to the Vice President for Academic Affairs.

Having discussed the most pressing issues of the Fall Institute activities and the Teacher of the Year procedures, President Kerr referred back to Agenda item II :

II. SIX KEY INITIATIVES & MILESTONES (ATTACHMENT A & D)......PRESIDENT KERR

Secretary Pier and Senator Ogar discussed the need to review the Key Initiatives and Milestones in order to set performance metrics and time frames. Creating, discussing and debating the new By-Laws is a major task which will set the framework for all of the HSSU Senate actions. It also involves an overhall of the established committees in their relationship to the shared governance of the university.

We are at the beginning of a process which will continue to evolve as we survey the faculty, implement strategies to support the faculty by developing a "viable template for shared governance, provide an outlet to air reasonable concerns and grievances regarding university issues" (Milestone 2) and "work with the administration to implement a higher level of shared governance between the administration and the faculty." (Milestone 3)

President Kerr agreed that we need to revamp the 2002 By-Laws. By October 20 we will have a draft for the By-Laws and eventually develop a constitution. This will be the top priority for the next meeting on September 14 from 2:30 - 3:30. This meeting will be open to respectful faculty involvement.

Senator Ogar suggested that he could send a letter to all senators to bring the draft together. He wants to set up specific tasks and, as necessary, set up private meetings beforehand to achieve the tasks before the next meeting. In the interests of time, the rest of the agenda was tabled to September 14.

Senator Omunwere moved to adjourn the meeting at 11:30. Senator Carr seconded the motion. The meeting was adjourned.

- The variety and complexity of the tasks performed by institutions of higher education produce an inescapable interdependence among governing board, administration, faculty, students, and others. The relationship calls for adequate communication among these components, and full opportunity for appropriate joint planning and effort (Statement of Government of Colleges and Universities, 1966).
- Shared Governance: Definition of Faculty Primacy Role
- American Association of University Professor's (AAUP) 1966 Statement on Government of Colleges and Universities: Faculty Primacy involves three areas: (1) curriculum, subject matter and methods of instruction, and research; (2) matters of faculty status (*e.g.*, hiring, dismissal, retention, tenure, and promotion), and (3) those aspects of student life that relate to the educational process (Source: AAUP "Indicators of Sound Governance," 2/12/2001).
- Association of Governing Boards (ACG): State Governance Action Report 2011
- In August 2011, Missouri Governor Jay Nixon convened his annual higher education summit, and created a new task force comprised of leaders from two- and four-year

institutions tasked with creating recommendations and metrics for evaluating performance.
