BLACK EXECUTIVE EXCHANGE PROGRAM (BEEP) TO BE HELD AT THE BUSINESS SCHOOL, OCTOBER 22-23

The Anheuser-Busch School of Business Administration will host a Black Executive Exchange Program (BEEP) conference on Wednesday, October 22, and Thursday, October 23.

BEEP is a voluntary partnership between the National Urban League, corporate America, government, nonprofits and other institutions to "loan" African-American executives to participating colleges as "Visiting Professors." Visiting Professors lecture in credit-bearing courses that correspond to their industries and participate in other BEEP-related activities such as networking sessions, workshops and mock job interviews. BEEP's mission is to share learning experience across generations, cultivate new leaders and inspire achievements "beyond the possible" through committed involvement and operational excellence.

ACKER AND KERR TO PRESENT AT AUPHA CONFERENCE

Dr. Larry Acker and Dr. Johndavid Kerr will present papers at the Association of University Programs in Health Administration (AUPHA) at a conference in October in Nashville, Tennessee. Dr. Acker's paper, coauthored with Dr. Charles Sykes, is titled "Recruitment and Retention in a Health Care Management Program." Dr. Kerr's paper is titled "Confronting Curricular and Learning Challenges In Healthcare Education: Dynamics, Pedagogy and Approaches." The AUPHA is the major accrediting body for health care management programs. Accreditation from the AUPHA will be sought by the Anheuser-Busch School of Business Administration's Health Care Management Program in the future.

AACSB PRE-ACCREDITATION WORKSHOP



Dr. Sykes Attended the Pre-Accreditation Workshop in Atlanta, GA, September 20-21, 2008. He reported that there are 555 accredited business schools, 458 United States schools and 96 outside of the United States in 32 countries. Dr. Sykes concluded by saying that if the institution is going to be successful in AACSB accreditation, full commitment is needed from the leaders of institution. The process would take at least five years complete.

LITC MEETING: LAUNCHING THE TAX CLINIC FOR THE 2009 TAX SEASON

A meeting was held on Thursday, September 18, 2008, at noon with Shelia Spiller of the IRA, Instructor Quintin Davis and Dr. Charles Sykes. Spiller reported that more than 500 tax returns were filed at the HSSU LITC Clinics, which saved the community approximately \$17, 000 in filing fees and generated much more than \$365, 000 to be put back into the community. For the second year, Davis has agreed to be the Site Coordinator for the LITC Clinic. He stated that the clinic would benefit both our students as well as our underprivileged community. He also said that the Busch School of Business would be the main site and the main campus would offer their support if space is available. At the close of the meeting, Spiller gave HSSU, represented by Dr. Sykes, a plaque for participating in the program. The meeting adjourned at 2 p.m.

IRS RECOGNIZES HARRIS-STOWE STATE UNIVERSITY

The IRS recognized Harris-Stowe State University for promoting the Earned Income Tax Credit and HSSU's Support of National Economic Stimulus Payment Day, March 29, 2008. The University was highlighted in the Internal Revenue Service SPEC Kansas City Territory Partner (Newsletter). The Newsletter stated that HSSU is a first-year partner and that Accounting Instructor Quintin Davis served as program administrator. Davis wants to establish a Tax Clinic for Low Income Taxpayers in conjunction with the IRS. HSSU e-filed more than 460 returns in 2008. JOB WELL DONE!
