

## **SGA & MAJESTIC ASSEMBLY CAMPAIGN/ELECTION RULES**

- **ALL ACTIVE CAMPAIGNING MAY BEGIN MONDAY, APRIL 14, 2008 AT 8:00 A.M. AND MUST CEASE BY 10:00 P.M. DAILY, WITH THE EXCEPTION OF ELECTION DAY (8:00 A.M. - 6:00 P.M.). ACTIVE CAMPAIGNING INCLUDES, BUT IS NOT LIMITED TO, DISTRIBUTING NAME TAGS, SINGING, AND HANGING POSTERS.**
- **CANDIDATES ARE RESPONSIBLE FOR ANY CAMPAIGNING DONE ON THEIR BEHALF.**
- **ALL CAMPAIGN MATERIALS MUST BE IN GOOD TASTE, AS STATED AND/OR IMPLIED BY THE COLLEGE.**
- **CAMPAIGNING IS NOT PERMITTED WITHIN DETERMINED AND PREMARKED AREAS AROUND VOTING TABLE. (CAMPAIGNING CONSISTS OF ANY LITERATURE, ETC., BEARING CANDIDATES NAME AND /OR LIKENESS IN AN EFFORT TO SECURE VOTES.**
- **THE CHAIRPERSON OF THE ELECTION COMMITTEE SHALL BE RESPONSIBLE FOR APPROVING ANY AND ALL DEMONSTRATIONS, RALLIES AND USE OF LOUD SPEAKING EQUIPMENT.**
- **CANDIDATES ARE RESTRICTED TO 10 POSTERS (NO LARGER THAN 14x36 INCHES) TO PROMOTE THEIR CAMPAIGN. NO POSTER MAY BE TAPED ON PAINTED SURFACES. ONLY 1 BANNER (NO LONGER THAN 3 FEET LONG) AND 1 POSTER WILL BE ALLOWED FOR EACH CANDIDATE TO BE DISPLAYED IN THE ANNEX OR ON THE CAFETERIA BULLETIN BOARDS. ALL POSTINGS MUST BE STAMPED IN THE OFFICE OF STUDENT ACTIVITIES.**
- **NO POSTINGS ARE ALLOWED ON ENTRANCE/EXIT DOORS OR WALLS.**
- **CANDIDATES SHOULD REMOVE ALL POSTED SIGNS, ETC. FOLLOWING ELECTIONS.**
- **BALLOTING SHALL BE BY SECRET BALLOT BETWEEN THE HOURS OF 10:00 A.M. AND 6:00 P.M. NO ONE SHALL VOTE WITHOUT PRESENTING HIS/HER IDENTIFICATION OR CURRENT STUDENT I.D. VOTING SHALL BE DONE ON THURSDAY, APRIL 17, FRIDAY, APRIL 18, AND SATURDAY, APRIL 19, 2008.**
- **FACULTY, ADMINISTRATORS, OR SUPPORT STAFF SHALL NOT BE ELIGIBLE TO VOTE IN THE ELECTIONS, UNLESS THEY ARE REGISTERED STUDENTS AT HARRIS-STOWE STATE UNIVERSITY.**
