## PART I

### **HARRIS-STOWE STATE UNIVERSITY SCHOLARSHIP DESCRIPTIONS**

#### **Awarded through the HSSU Scholarship Committee**

**The Zola M. Aldridge Early Childhood Education Scholarship** was established in December 2007 by the family of Zola M. Aldridge to honor her years of service as an early childhood educator in East St. Louis, IL. Aldridge has dedicated her life to caring for and educating children in underserved communities. The \$400 per year scholarship, \$200 per semester, will be awarded to a full-time Early Childhood Education student in good standing at Harris-Stowe State University. Recipients must meet all of the scholarship requirements established by the HSSU Scholarship Committee. Submit applications to the HSSU Scholarship Committee.

**Alumni Association Scholarship:** The Harris-Stowe State University Alumni Association Scholarship is funded by an annual donation from the HSSU Alumni Association and interest from an endowment fund. There is a total of six scholarships available: four book scholarships at \$500 each and two additional awards in the amount of \$4,000 each that can be used toward funding in-state tuition and admission fees for 12 to 16 credit hours per semester. Each scholarship is split between two semesters so that funds can be awarded for the fall and the spring. To be eligible, an applicant must be degree-seeking and have a minimum 3.0 CGPA after completing 24 credit hours at HSSU. For the \$4,000 scholarship, the HSSU Scholarship Committee presents a minimum of three nominees to the Alumni Association Scholarship Committee who selects their scholar. If funds are available, a recipient who remains continuously enrolled may receive this scholarship for a total of two semesters as long as he or she attains a 3.0 GPA for the semesters awarded and continues to make satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**The Lisa A. Anderson Memorial Scholarship** is a \$500 per year scholarship honoring the memory of Lisa A. Anderson, a former Harris-Stowe State University employee. Recipients must be Teacher Education or Urban Specializations majors, attending full-time and have a CGPA of at least 2.75. Submit applications to the HSSU Scholarship Committee.

**Ballwin-Chesterfield AAUW Scholarship** is funded through biannual donations of \$250 from the Ballwin-Chesterfield Branch of the American Association of University Women. This \$250 per semester scholarship covers a portion of in-state tuition and or books for two semesters. To be eligible, an applicant must be a degree-seeking student enrolled in a minimum of six credit hours with a minimum 3.0 CGPA, with unconditionally satisfactory progress and have a demonstrated financial need. Submit applications to the HSSU Scholarship Committee.

**Bertha Black Rhoda Top Ladies of Distinction Scholarship** is funded by an annual donation to HSSU. This scholarship funds a portion of in-state tuition and admission fees for one semester. To be eligible, an applicant must be a degree-seeking student with a minimum 3.0 CGPA and must make unconditionally satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**Bertha Black Rhoda, National Council of Negro Women Inc. Scholarship** is funded by an annual donation to HSSU. This Scholarship funds a portion of in-state tuition and admission fees for one semester. Submit applications to the HSSU Scholarship Committee.

**Delta Kappa Gamma, Zeta Chapter Scholarship** is funded by a donation to HSSU. This scholarship funds a portion of the in-state tuition and admission fees for one semester. To be eligible, an applicant must be a degree-seeking female student majoring in Education, who is entering her junior year at HSSU and who is making unconditionally satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**The Mattie L. Evans Memorial Scholarship** is funded by Attorney and Mrs. David R. Hess in honor of a truly dedicated woman who loved education and inspired young people throughout the community. The recipient must meet the following criteria: (1) major in Early Childhood Education; (2) maintain a CGPA of at least 2.8 on a 4.0 scale; (3) be enrolled at the University as a junior or senior; (4) have demonstrated an abiding commitment to teaching and working with young children and (5) provide evidence of financial need. Submit applications to the HSSU Scholarship Committee.

**The Fred and Corinne Brooks Memorial Scholarship** at Harris-Stowe State University was established in 2003 by Dr. Gretchen C. Lockett, faculty member and administrator at the University, in memory of her parents who cherished education. The scholarship is a one-time award of \$100 for books to juniors or seniors with a CGPA of 2.3 or better and who have been accepted into their professional program. Up to seven students may be awarded these funds per semester. Submit applications to the HSSU Scholarship Committee.

**Faculty and Staff Scholarship** is funded by annual contributions from the HSSU faculty and staff. This variable scholarship may be applied toward in-state tuition, admission fees and or required textbooks. An applicant must be a full-time student who has completed at least 12 credit hours at HSSU. Additionally, an applicant must have a minimum 3.0 CGPA and must maintain unconditionally satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**The Givens Memorial Scholarship:** The Catherine and Henry Givens Sr. Scholarship is funded by the Givens family. The \$500 per semester scholarship can be applied to in-state tuition and fees. To be eligible, an applicant must have completed two semesters and have a minimum 3.0 CGPA. Additionally, an applicant must display involvement in University activities. If funds are available, a recipient who remains continuously enrolled may receive this scholarship for a total of two semesters as long as he or she maintains a 3.0 CGPA while completing at least 12 credit hours per semester and continuing to make unconditionally satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**Harris-Stowe State University Miscellaneous Scholarship** is funded by current gifts and interest from an endowment fund. Scholarships range from \$200 to \$500 and may be awarded by the HSSU Scholarship Committee at its discretion. The scholarship may be given in cases of unusual need or superior scholarship. An applicant must be a full-time student who has completed at least 12 credit hours at HSSU and is making satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**Ladue Chapel Scholarship for Excellence in Business** is funded by the Ladue Chapel Presbyterian Church and was established in November 2002. This \$5,000 per year scholarship,

\$2,500 per semester, can be applied toward tuition, up to 15 hours; related fees; textbooks and to the extent possible, a transportation stipend equal to the cost of a bus pass for the semester. To be eligible, an applicant must be African-American, have a minimum CGPA of 3.0, be entering his or her junior year of a Business degree program and be willing to state, in writing, that he or she commits to give community service while in college and after graduation and declare, in writing, his or her intent to enter the business world of greater St. Louis upon graduation. A recipient who remains continuously enrolled may receive this scholarship for a total of four semesters (summer sessions not included) as long as he or she remains in good standing and maintains a 3.0 CGPA. Submit applications to the HSSU Scholarship Committee.

**Lamar and Shaw Memorial Scholarship:** The Aline Lamar and Norton Shaw Memorial Scholarship is funded by an endowment fund. Mr. and Mrs. Horace Wilkins and his employer, Southwestern Bell Telephone Company, donated the funds to Harris-Stowe so the University could establish a scholarship for academically talented students. The \$3,000 per year scholarship, \$1500 per semester, covers full-time, in-state tuition, up to 16 credit hours; admission fees; required textbooks and to the extent possible, some incidentals. To be eligible, an applicant must have a minimum 3.0 CGPA. A recipient who remains continuously enrolled may receive this scholarship for a total of eight semesters as long as he or she maintains a 3.0 CGPA while completing at least 12 credit hours per semester. Submit applications to the HSSU Scholarship Committee.

**The Ella Marth Memorial Scholarship** is funded by the interest from an endowment fund honoring the memory of a former member of the HSSU faculty. Dr. Marth served from 1945 to 1953 at Harris Teachers College as a member of the mathematics faculty. The \$1,000 per year scholarship, \$500 per semester, can be applied toward full-time, in-state tuition and admission fees, required textbooks and to the extent possible, some incidentals. To be eligible, an applicant must have completed a minimum of 65 college-level credit hours with a minimum 3.0 CGPA, have been admitted to a Teacher Education program and must have declared mathematics and or science as an area(s) of concentration. Additionally, an applicant must present a letter of recommendation from an instructor in the HSSU math/science division attesting to the applicant's potential as a math and or science teacher. A recipient who remains continuously enrolled may receive this scholarship for a total of four semesters, as long as he or she continues to make unconditionally satisfactory academic progress. The mathematics and science faculty may make nominations to the HSSU Scholarship Committee for this scholarship. Submit applications to the HSSU Scholarship Committee.

**The Michael McMillan Scholarship** was established in March 2007 by Michael McMillan, License Collector of the City of St. Louis, in collaboration with the Collegiate 100. Recipients must be full-time Business Administration students with a minimum 3.0 CGPA. Scholarship recipients are chosen based on their academic excellence, community service and have an interest in public service. Submit applications to the HSSU Scholarship Committee.

**The Palmer Family Scholarship Fund** was established in January of 2005 by Mr. and Mrs. Frederick D. Palmer for deserving Harris-Stowe State University students pursuing a degree in Business. This \$2,500 per semester scholarship covers in-state tuition, fees and when possible, some books. Recipients must be attending full-time students with a minimum 3.0 CGPA. Submit applications to the HSSU Scholarship Committee.

**The Peabody Energy Scholarship** is awarded to a student majoring in Business Administration, with a CGPA of 3.0. This scholarship covers the total cost of tuition, fees and books. Submit applications to the HSSU Scholarship Committee.

**The Richard “Ricky” Towns Scholarship:** This annual \$500 scholarship honors the memory of Richard “Ricky” Towns, Harris-Stowe State University graduate and music educator in the St. Louis Public Schools. The recipient must be an undergraduate majoring in Teacher Education or Urban Education, actively involved in the Concert Chorale and or the Gospel Choir, enrolled in a minimum of 12 credit hours, maintain at least a 2.5 CGPA, demonstrate financial need and be of good moral character with interest in continuation in the music field. Submit applications to the HSSU Scholarship Committee.

**The Shelton Memorial Scholarship:** The Richard R. Shelton Memorial Scholarship is funded by an endowment fund. The family and employer (IBM) of Richard Shelton, a Harris Teachers College graduate, donated the funds for the University to establish a scholarship for academically talented students majoring in Teacher Education. The \$1,000 per year scholarship, \$500 per semester, can be applied toward full-time, in-state tuition, admission fees and to the extent possible, required textbooks. To be eligible, an applicant must have a minimum 3.0 CGPA, be admitted into a Teacher Education program and provide a letter of recommendation from a faculty member. A recipient who remains continuously enrolled may receive this scholarship for a total of four semesters, excluding summer sessions, as long as he or she maintains a 3.0 CGPA, while completing at least 12 credit hours a semester. Submit applications to the HSSU Scholarship Committee.

**The Shepley Memorial Scholarship:** The Ethan A. Shepley Memorial Scholarship is funded by an endowment fund. The \$1,500 per year scholarship, \$750 per semester, can be applied toward in-state tuition and admission fees, required textbooks and to the extent possible, some incidentals. To be eligible, an applicant must have a minimum 3.0 CGPA and must have completed 12 credit hours at the college level. Additionally, an applicant must display a concern for the progress of young people and the ability to work with peers and instructors. A recipient who remains continuously enrolled and continues to meet the eligibility requirements may receive this scholarship for a total of four semesters, excluding summer sessions, as long as he or she maintains a 3.0 CGPA while completing at least 12 credit hours per semester. Submit applications to the HSSU Scholarship Committee.

**The Norman J. Stupp Scholarship** is funded by the interest from an endowment fund honoring Norman J. Stupp, a St. Louis educator. The \$750 per year scholarship can be applied toward in-state tuition, admission fees and to the extent possible, required textbooks. To be eligible, an applicant must have completed at least 24 credit hours and less than 45 credit hours, have a minimum 3.0 CGPA and must maintain unconditionally satisfactory academic progress. If funds are available, a recipient who remains continuously enrolled may receive this scholarship each semester for two full-time semesters, excluding summer sessions, as long as he or she continues to make unconditionally satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**The Victor J. Thompson Endowed Scholarship Fund** was established in December 2001 by Mr. and Mrs. Paul Fleischut, in honor of Mrs. Fleischut’s father, Victor J. Thompson, who graduated from Harris Teachers College in 1964. The Victor J. Thompson Scholarship Award is currently a \$150 annual award to a qualified student majoring in Teacher Education, K-12, at Harris-Stowe State University. Recipients of this scholarship award must meet all of the

scholarship requirements established by the Harris-Stowe Scholarship Committee. In addition, preference will be given to a student who is planning to teach in an urban school district. Submit applications to the HSSU Scholarship Committee.

**Tom Joyner Academic Excellence Scholarship** is funded by the Tom Joyner Foundation. It is presented to a student who has shown academic excellence. The recipient must be admitted as a full-time, degree-seeking student with a minimum 3.5 CGPA. This scholarship covers full-time, in-state tuition and fees. Submit applications to the HSSU Scholarship Committee.

**John H. Ward Memorial Scholarship** is funded by a donation from Ollie Tucker-Ward, honoring John H. Ward, a St. Louis entrepreneur. The \$500 per year scholarship can be applied toward out-of-state tuition, books and to the extent possible, incidentals. To be eligible, an applicant must be an international student, have a minimum 3.0 CGPA and must be making unconditionally satisfactory academic progress. If funds are available, a recipient who remains continuously enrolled may receive this scholarship each semester for two semesters, excluding summer sessions, as long as he or she continues to make unconditionally satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**The Nadia Whitmore Family Scholarship** is funded by donations made throughout the year. Recipients must be a junior or senior majoring in Criminal Justice, admitted as a full-time student and maintain a minimum CGPA of 3.0. Submit applications to the HSSU Scholarship Committee.

**The JoAnn Williams Family Scholarship** is funded by the JoAnn Williams Family. The scholarship was designed to assist a student with the expenses related to completing a bachelor's degree. Recipients must be majoring in Teacher Education with a Science emphasis and maintaining a CGPA of at least 3.0. Submit applications to the HSSU Scholarship Committee.

**The Odessa Nobles Costello Memorial Scholarship** is a \$1,000 per year, \$500 per semester, scholarship for a selected student from Sumner High School or Beaumont High School who has demonstrated the most academic improvement in the last year and enrolls in a program at Harris-Stowe State University. Recipients can be majoring in any discipline, enrolled full-time and maintaining at least a CGPA of 2.5. Submit applications to the HSSU Scholarship Committee.

**The Marguerite Bieler Notorangelo Educator Scholarship** was established in January 2010 by Anthony Notorangelo in honor of Marguerite Bieler Notorangelo, a 1940 graduate of Harris Teachers College, to honor her many years of service as an elementary school teacher. The \$3,000 per semester scholarship for incoming and continuing students may be applied to cover full-time, in-state tuition, up to 16 credit hours; admission fees; required textbooks and to the extent possible, some incidentals. If funds are available, a recipient who remains continuously enrolled may receive this scholarship for a total of eight semesters as long as he or she maintains a 2.7 CGPA while completing at least 12 credit hours per semester and continuing to make unconditionally satisfactory academic progress toward a bachelor's degree in Teacher Education. The scholarship recipient is chosen based on academic excellence, community service, a showing of a sincere desire and passion to teach at any level, pre-K through high school. The application will ask for a second essay (in addition to the one required of all scholarship applicants) of no more than one typed page which addresses the following questions:

- What traits and or qualities do you believe a good teacher should possess?
- Drawing from your own experiences, how are you preparing yourself to become the good teacher you described in the first question?

**The Minnie Liddell Scholarship**, established in August of 2007, shall be awarded annually to a deserving student. Recipients will be required to maintain a 2.5 CGPA and be enrolled in at least six credit hours.

**The Prince Hall Lodge Scholarship** was established in 2007 by the members of The Most Worshipful Prince Hall Grand Lodge of Missouri; this \$500 scholarship will be awarded annually. The recipient must be a continuing student maintaining at least a 2.5 CGPA and enrolled full-time. The student should demonstrate in his or her character the virtues of temperance, fortitude, prudence and justice.

**The Promethian's Inc. Scholarship** is funded by Promethian's Inc. The scholarship provides \$2,000 per year, \$500 per semester, for two selected students in need. Recipients must be majoring in Education, enrolled full-time, maintaining a CGPA of least 2.5 and be of good moral character. Submit applications to the HSSU Scholarship Committee.

## PART II

### **HARRIS-STOWE STATE UNIVERSITY AWARD DESCRIPTIONS**

#### **Awarded through the HSSU Scholarship Committee**

**Carla Cunningham Foundation Special Incentive Award:** This \$1,500 annual award, established by the Carla Cunningham Foundation in April 2002, encourages single mothers to pursue degrees in higher education. The recipient must be a single mother, divorced or never married, of one or more children. She must be a student in good standing, enrolled in 12 credit hours or more per semester in a degree program at Harris-Stowe State University and has demonstrated the ability to succeed. The required GPA for this award is C (2.0) or better. The Carla Cunningham Foundation Special Incentive Award is given in two installments: \$750 at the beginning of the first semester and \$750 at the beginning of the second semester, contingent on the recipient's continuing eligibility. Submit applications to the HSSU Scholarship Committee.

**The Sandra M. Reid Memorial Scholarship** was established to honor the memory of Sandra M. Reid. A continuing Harris-Stowe State University student will be awarded this scholarship annually. The recipient must maintain a 2.5 CGPA and be enrolled in at least 12 credit hours.

**Harris-Stowe State University Miscellaneous Award** is funded by current gifts and interest from an endowment fund. Awards range from \$200 to \$500 and may be given by the HSSU Scholarship Committee at its discretion. This award may be presented to students due to an unusual need or because of superior scholarship. An applicant must be a full-time student who has completed at least 12 credit hours at HSSU. Additionally, a student must be making satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**Harris-Stowe State University Board of Regents Award:** The Harris-Stowe State University Board of Regents may make full awards and partial awards to deserving changes. To be eligible, an applicant must have completed six college-level credit hours and must have a minimum 2.5 CGPA. Continuing students must be making satisfactory academic progress. Additionally, applicants must demonstrate financial need and provide a letter of recommendation evaluating the applicant's desire and potential to complete the baccalaureate degree. Submit applications to the HSSU Scholarship Committee.

**The Ingram Family Book Award** was established in June 2009 by Dr. John Ingram Jr. to honor the memory of his parents, John and Catherine Ingram. The recipient must be a Teacher Education major, junior or senior level, enrolled in a minimum of 12 credit hours per semester and maintaining at least a 2.5 GPA before and during the period covered by the scholarship. This \$500 award will be equally distributed as a \$250 award for both fall and spring semesters.

**The Mashon Nelson Award** is funded by contributions made in memory of Mashon Nelson, who was an instructor in the Academic Support Programs at Harris-Stowe State University from 1988 to 1996. Nelson was committed to working with African-American male students who needed special academic support to reach their potential so they could become role models for their children and serve their communities as the leaders of tomorrow. This award will provide \$25 per year to a sophomore student who is an African-American male, has a CGPA of 2.5 or above, has shown leadership potential and has demonstrated his ability to overcome academic



barriers to undertake additional work in higher education. To receive this award for the second semester, the student must have a CGPA of 2.5 or above at the end of the previous semester for which he received this award. The HSSU Student Government Association (SGA) may nominate candidates for this award. The SGA president informs nominees to *submit completed applications to the Director of Academic Support Programs, who will submit applications to the HSSU Scholarship Committee.*

**George H. Pruitt Memorial Award:** The Reverend George H. Pruitt Memorial Award is funded by donations from members of Acacia Lodge #166. This \$1,000 per year award can be applied toward in-state tuition, admission fees and to the extent possible, required textbooks for a full-time, degree-seeking student. To be eligible, applicants must have completed at least one semester at HSSU, have a minimum 2.5 CGPA, be making satisfactory academic progress, be enrolled in either the Teacher Education or Urban Specializations program, have participated in college and or community activities and demonstrate financial need. If funds are available, a recipient who remains continuously enrolled may receive this award for each semester for eight full semesters, excluding summer sessions, as long as he or she continues to maintain a minimum 2.5 OCGPA and continues to make satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**The Dr. Katie Harper Wright Special Education Award** was established in April 2002 by Dr. Katie Harper Wright — educator, journalist, community leader and former member of the Harris-Stowe State University adjunct faculty — to encourage students to pursue careers in special education. The recipient of this \$300 annual award must be a full-time Teacher Education student in good standing at Harris-Stowe who is pursuing the option in special education. Recipients must also meet all of the scholarship requirements established by the Harris-Stowe Scholarship Committee. The award is distributed in two parts: \$150 at the beginning of the first semester and \$150 at the beginning of the second semester. Submit applications to the HSSU Scholarship Committee.

**Delester Briggs Young Book Award** is funded by the Delester Briggs Young family. It is a one-time award of \$100 for books to full-time students majoring in Elementary Teacher Education with a CGPA of at least 3.0. Submit applications to the HSSU Scholarship Committee.

## **PART III**

### **HARRIS-STOWE STATE UNIVERSITY PRIZE DESCRIPTIONS**

#### **Awarded through the HSSU Scholarship Committee**

**The Ernest Cox Prize** is funded by interest from an endowment fund established in honor of educator Ernest Cox. To be eligible for this annual \$100 prize, an applicant must have a minimum 3.0 CGPA and must have been admitted into the Teacher Education program. The Teacher Education faculty may make nominations to the HSSU Scholarship Committee for this prize. Submit applications to the HSSU Scholarship Committee.

**The Educators, Alumni and Friends Memorial Prize** is funded by the interest from an endowment fund originally established by the University with the combined gifts given in memory of Gwen B. Giles, Reba Mosby, John B. Ervin, Gertrude Cunningham, Deverne Calloway, Ruth Harris, Julia Davis and Josephine Herman. To be eligible for this annual \$100 prize, an applicant must have a minimum of a 3.0 CGPA, been admitted into the Teacher Education program and must maintain unconditionally satisfactory academic progress. The Teacher Education faculty may make nominations to the HSSU Scholarship Committee. Submit applications to the HSSU Scholarship Committee.

**Honda Campus All-Star Challenge Prize** is funded annually by the Honda Corporation based on Harris-Stowe's participation in the Honda All-Star Challenge. To be eligible for one of 10 annual \$100 prizes, an applicant must have a minimum 3.0 CGPA and must have completed a minimum of three college credit hours. Preference will be given to applicants not receiving any other source(s) of financial assistance. The Honda All-Star Committee may make nominations to the HSSU Scholarship Committee for the prizes. Submit applications to the HSSU Scholarship Committee.

**The Eva Marie James Memorial Prize** is funded by the interest from an endowment fund established in memory of Eva James, a former member of the Teacher Education faculty. To be eligible for this annual \$50 prize, an applicant must have a minimum of a 3.0 CGPA and have demonstrated excellence in language arts and children's literature. The Teacher Education faculty may make nominations to the HSSU Scholarship Committee for this scholarship. Submit applications to the HSSU Scholarship Committee.

**The Eva Marie Moore Prize** is funded by interest from an endowment fund established by the mathematics faculty to honor Dr. Marie Moore, a past chairperson of the Mathematics Department. To be eligible for this annual \$100 prize, an applicant must be a junior or senior, have a minimum of a 3.0 CGPA and have demonstrated excellence in mathematics. The mathematics faculty may make nominations to the HSSU Scholarship Committee for this prize. Submit applications to the HSSU Scholarship Committee.

**The Eric Mosely Prize** is funded by interest from an endowment fund established in honor of Eric Mosely. To be eligible for this annual \$100 prize, an applicant must be a junior or senior, have a minimum of a 3.0 CGPA and have demonstrated excellence in computer science. The computer science faculty may make nominations. Submit applications to the HSSU Scholarship Committee.

**The Nicholson Prize:** The Lawrence E. Nicholson Prize is funded by the interest from an endowment fund established by Dr. Lawrence E. Nicholson, a retired professor of psychology. To be eligible for this annual \$50 prize, applicants must be juniors or seniors, have a minimum of a 3.0 CGPA and have demonstrated excellence in psychology. Additionally, applicants must display community/University involvement. The psychology faculty may make nominations to the HSSU Scholarship Committee for this prize. Submit applications to the HSSU Scholarship Committee.

**Poro Club's Middlebrook Memorial Prize** is funded by the interest from an endowment fund established by a gift from the Poro Club to honor Thenia Carr Middlebrook. To be eligible for this annual \$50 prize, an applicant must have a minimum of a 3.0 CGPA. Submit applications to the HSSU Scholarship Committee.

**The Joseph D. Rodgers Prize** is funded by the interest from an endowment fund established in honor of educator Joseph D. Rodgers. To be eligible for this annual \$75 prize, applicants must be juniors or seniors, have a minimum 3.0 CGPA and have demonstrated excellence in Teacher Education. The special education faculty may make nominations to the HSSU Scholarship Committee for this prize. Submit applications to the HSSU Scholarship Committee.

**The Inez Specking Prize** is funded by the interest from an endowment fund established in honor of educator Inez Specking. The English faculty may nominate one student to receive this annual prize of \$100. Applicants must have a minimum 3.0 CGPA. Submit applications to the HSSU Scholarship Committee.

**The Surafiel Memorial Prize** is funded by the interest from an endowment fund established in memory of Menbere Miriam Surafiel, a past member of the social sciences faculty. To be eligible for this annual \$50 prize, an applicant must have a minimum 3.0 CGPA, have an interest in international student activities and have demonstrated excellence in social sciences. The social sciences faculty may make nominations to the HSSU Scholarship Committee for this prize. Submit applications to the HSSU Scholarship Committee.

**Jason Anthony Veal Scholarship Fund** has been established in memory of Jason A. Veal, who was a high school student at Roosevelt High School. To be eligible for this annual scholarship of \$1,250, an applicant must be a graduate of Cleveland ROTC High School or Roosevelt High School, must be admitted as a freshman at Harris-Stowe State University, must have the expressed intention of majoring in Teacher Education or Business Administration, must be enrolled in at least 12 hours per semester at Harris-Stowe, must have a cumulative GPA 2.5 and must show community service. Submit applications to the HSSU Scholarship Committee.

**The Winters Memorial Prize:** The Ronald Winters Memorial Prize is funded by the interest from an endowment fund established in honor of Mr. Ronald Winters, a former HSSU student. To be eligible for this annual \$50 prize, an applicant must be a junior or senior, have a minimum 3.0 CGPA and maintain satisfactory academic progress. Additionally, an applicant must display interest and involvement in youth activities. Submit applications to the HSSU Scholarship Committee.

## PART IV

### **HARRIS-STOWE STATE UNIVERSITY SCHOLARSHIP AND AWARD DESCRIPTIONS**

**Des Lee Foundation Scholarship** is for a first-time freshman or transfer student, who is in Business Administration or related field, who graduated in the upper 25 percent of high school class and an ACT of 20 or higher or the equivalent of the two. The scholarship is in the amount of \$1,500 per semester, which is to cover tuition, fees and books, if possible. If funds are available, a student can receive the scholarship for two semesters as long as a CGPA of 3.0 is maintained and the student makes satisfactory academic progress. Submit applications to the HSSU Scholarship Committee.

**Fox Family Foundation Scholarship** is for a first-time freshman who is enrolled in Business Administration or related field, graduated in the upper 25 percent of his or her high school class and has an ACT score of 20 or higher, or an equivalent of the two.

**The Andrew and Mathilda Burke Memorial Scholarship** is funded by the Burke and Besson families. To be eligible for this \$1,000 per-year scholarship, a recipient must be a full-time degree-seeking junior or senior, have a minimum CGPA of 3.0 and make unconditionally satisfactory academic progress. Additionally, the applicant must show involvement in the community and or University activities.

**Harris-Stowe State University Academic Performance Award:** The Harris-Stowe State University Director of Enrollment Management awards a limited number of academic performance awards to incoming first-time freshmen and transfer students. This partial award covers in-state tuition and fees. Recipients enrolled in six to 16 credit hours will have 50 percent of their in-state tuition and fees paid. A recipient who remains continuously enrolled may receive this award each semester until he or she has completed the number of credit hours required by his or her degree program. Recipients must maintain a minimum 2.0 CGPA and continue to make unconditionally satisfactory academic progress. To be eligible, first-time freshman and transfer students with fewer than 24 college credit hours must have a minimum ACT score of 20 and a minimum 2.5 high school CGPA. Transfer students with more than 24 college credit hours must have a minimum ACT score of 20 and a minimum 2.7 CGPA. **Apply directly to the Director of Enrollment Management, who makes awards subject to final compliance and budgetary approval by the HSSU Scholarship Committee.**

**Harris-Stowe State University Board of Regents Scholarship** is awarded through the Office of Admissions; this scholarship is awarded to six students. The \$2,000 per semester scholarships covers full-time, in-state credit hour fees and to the extent possible, required textbooks and other costs of attendance. To be eligible for consideration, an applicant must be admitted as a full-time, degree-seeking student with a minimum 3.0 CGPA and an ACT score of 21 or higher. If funds are available, a recipient who remains continuously enrolled may receive this scholarship each semester for eight full-time semesters (excluding summer sessions), as long as he or she continues to make satisfactory academic progress, maintains a 3.0 CGPA and submits a renewal application.

**Harris-Stowe State University Incentive for Excellence Scholarship:** The Harris-Stowe State University director of Enrollment Management awards a limited number of full scholarships to

incoming freshmen and transfer students. Recipients enrolled in six to 16 credit hours will have 100 percent of their in-state tuition and admission fees paid. A recipient who remains continuously enrolled may receive this scholarship each semester until he or she has completed the number of credit hours required by his or her degree program. Recipients must maintain a minimum 3.0 CGPA and continue to make unconditionally satisfactory academic progress. To be eligible, an applicant must meet the following academic requirements: ACT score of 21-22/minimum and 3.5 CGPA, ACT score 23-24/minimum and 3.0 CGPA or ACT score of 25 or higher/minimum and 2.5 CGPA. **Apply directly to the director of Enrollment Management, who makes awards subject to final compliance and budgetary approval by the HSSU Scholarship Committee.**

**Harris-Stowe State University Intercollegiate Athletic Awards:** The director of Athletics grants up to 68 athletic awards to cover in-state tuition and admission fees, up to 12 credit hours per semester and 68 book awards, covering up to \$100 for books per semester. Full and partial awards are made to new students who meet full-time admission requirements and National Association of Intercollegiate Athletics (NAIA) requirements. Full and partial awards are made to continuing students who meet NAIA requirements and are making satisfactory academic progress. A recipient who remains continuously enrolled and continues to make satisfactory academic progress may receive this award each semester for eight full-time semesters, excluding summer sessions, with the approval of the Director of Athletics. **Apply directly to the director of Athletics who makes awards subject to conference compliance, approval by the faculty athletic representative and final compliance and budgetary approval by the HSSU Scholarship Committee.**

**Harris-Stowe State University Leadership Award:** Harris-Stowe State University, through the Office of Admissions, awards a limited number of leadership awards to first-time freshmen and incoming transfer students. These awards may cover six to 12 in-state credit hour fees and admission fees. To be eligible for consideration, an applicant must be eligible for full-time admission to the University and complete a leadership award application. In addition, first-time freshmen and incoming transfer students with less than 24 credit hours must have completed the high school core curriculum as specified by the Missouri Coordinating Board for Higher Education. If funds are available, a recipient who remains continuously enrolled may apply to renew this award each semester until he or she has completed the number of credit hours required by his or her degree program, provided the recipient maintains a minimum 2.5 CGPA, continues to make satisfactory academic progress and continues to provide documentation of leadership in extracurricular/community activities. Submit applications for renewal to the HSSU Scholarship Committee.

**Harris-Stowe State University Concert Chorale Award:** The Harris-Stowe State University Concert Chorale director grants up to 15 music awards to cover in-state tuition and admission fees, up to 12 credit hours per semester. To be eligible, an applicant must display vocal talent, show evidence of making a positive contribution to the Concert Chorale and have a minimum of a 2.0 CGPA. Continuing students must be making satisfactory academic progress. A recipient who remains continuously enrolled and continues to make satisfactory academic progress may receive this award each semester until he or she has completed the number of credit hours required by his or her degree program. **Apply directly to the director of the Concert Chorale, who makes awards subject to final compliance and budgetary approval by the HSSU Scholarship Committee.**

**Harris-Stowe State University President's Award:** Harris-Stowe State University provides a limited number of these awards to assist eligible students in paying for in-state tuition and admission fees. This award covers the cost of in-state tuition, from three to 12 credit hours per semester. An applicant must be a degree-seeking or a certification-seeking student with a minimum 2.5 CGPA and must be making satisfactory academic progress. An applicant must NOT be receiving other grants, loans, awards or scholarships, which collectively cover the cost of 12 credit hours during the semester under consideration. Additionally, an applicant must have applied for the Federal Pell Grant. Students who already have a degree are exempt from this requirement. Applicants must reapply for this award each semester. **Submit applications to the Office of the President or appointed representative.**

**Harris-Stowe State University Professional Development Award:** The Harris-Stowe State University registrar awards a limited number of awards to individuals employed in school districts in the metropolitan St. Louis area. A maximum of three credit hours may be awarded to individuals who have not attended HSSU within the past two years. Partial awards of up to 50 percent of three credit hours may be awarded to individuals who have attended HSSU within the past two years. Additionally, special preapproved groups may receive up to three credit hours. **Apply directly to the Registrar, who makes awards subject to final compliance and budgetary approval by the HSSU Scholarship Committee.**

**Harris-Stowe State University Speech/Theater Award:** The HSSU theater director grants up to six theater awards to cover in-state tuition and admission fees, up to 12 credit hours per semester. To be eligible, an applicant must display theater-related talent, show evidence of making a positive contribution to theater arts at HSSU, have a minimum 2.5 CGPA and be enrolled in a speech or theater course and or be an active member of the HSSU Players theater group. Continuing students must be making satisfactory academic progress. A recipient who remains continuously enrolled and continues to make satisfactory academic and artistic progress may receive this award each semester until he or she has completed the number of credit hours required by his or her degree program. **Apply directly to the theater director who makes awards subject to final compliance and budgetary approval by the HSSU Scholarship Committee.**
